4 ON 4 Flag Football Rules Field of Play -30 x 70 plus 8 yard end zones. -Cones will mark all corners, mid field, and 5 yard boxes. *Flag belts must be worn with sockets facing outward. -Players must wear the same color jerseys. *Shirts must not hang down over flags or over shorts (must be tucked in at all times or tied above the belt line).
